On June 30, 2006 the Catholic Schools Foundation of Winona completed the nineteenth year of service to students, schools and donors of the Winona area. Over that same time period permanently restricted assets of this endowment have grown to exceed \$4,500,000 with distributions to the schools in excess of \$2,000,000.

The market was good to the foundation again this year and we were able to distribute just over \$130,000 to benefit Cotter High and the Winona Area Catholic Schools. We are thankful for donations received through Seeds of Faith which now total just over \$400,000 in donations to CSF. Thank you to the Pastors and Parish councils who helped dedicate these funds.

Through the Fr. Paul Nelson Legacy Society we have raised awareness of the powerful gift of deferred giving. Twenty six members have now made a future commitment to CSF. Please consider CSF when you are making your estate plans.
